This contract shall be governed by and constructed in accordance with the laws of the state of California and the parties consent to the jurisdiction of the courts of the State of California. No oral representations shall be binding unless set forth herein. G&F Concrete Cutting, Inc.'s liability and responsibility shall be limited strictly and solely to acts of omission of G&F Concrete Cutting, Inc.'s direct employees, anything in the purchase order or contract notwithstanding. We are not responsible for damage to any pipes, conduits, etc. in slabs, walls or under earth's surface or delays due to equipment malfunctions, weather or other causes beyond our control.
